The function relies on the action of a pneumatic piston vented on both sides. Alternating ventilation moves the pneumatic piston up and down. The movement generated in this process is transferred to the gripper jaws by kinematics, producing the gripper jaw movement. For grippers with an integrated spring, this spring supports the grip force, acting in the force-transfer direction. The spring used in the cylinder chamber in the GP1200 designs acts as an energy accumulator and gripping force safety device

Fig. 1: GP1200 gripper series



7.1 Installation of the mechanical system

The gripper must be installed on a mounting surface in accordance with the specifications for flatness

Length < 100 mm → permitted unevenness < 0.02 mm Length > 100 mm → permitted unevenness < 0.05 mm

- Pins and screws are not included in the scope of delivery.
 Strength class of the mounting screws ≥ 8.8 (DIN EN ISO 4762)
